


TERMS & CONDITIONS:-

- It is clearly informed that the vehicles shall be offered for auction through open bidding on the above place and date. Interested parties can inspect the above vehicles in premises of Telephone Industries of Pakistan on any working day, (from Monday to Friday), from 08.00 Hrs to 16.00 Hrs as per address given above.
- Successful bidder will be responsible to pay excise duty tax (Token Tax Etc) if it was not paid.
- Auction shall be separately for each vehicle. Intending bidders who will participate in the auction must deposit **Rs. 25000/ for up to vehicles 1000CC and Rs. 30,000/- for vehicles above the 1000CC**, each as earnest money (refundable) in the shape of call deposit receipt/bank draft or pay order in favour of Telephone Industries of Pakistan.
- Bidder must bring original as well as attested photocopy of their CNIC and provide their complete address and telephone number.
